# **Technical Learning Center DBA Prospect College**

# RECAP from previous meeting(s):

At the June 8, 2023 public meeting, Dr. Toufanian asked the Commission to defer action on the request for closure while he awaited the final decision from the United States Department of Education on a request for reconsideration of participation.

The Title IV program response concluded in disallowing the institution to continue participation with accreditation. Subsequently, a request to withdraw accreditation was provided by the institution, and to move forward with an affirmative approval of the request for campus closure of the Technical Learning Center DBA Prospect College.

The Commission voted unanimously to approve the application for campus closure submitted by Technical Learning Center DBA Prospect College with the following conditions to be met no later than September 4, 2023:

# i. New Lines Institute for Strategy and Policy

New Lines Institute for Strategy and Policy submitted an application for Provisional licensure renewal to offer the degree program in Master of Arts in Strategy and Policy.

The Commission voted unanimously to approve the application for Provisional licensure submitted by New Lines Institute for Strategy and Policy for one (1) year, not to exceed June 30, 2024.

## ii. International Teachers University

International Teachers University submitted an application for Provisional licensure to offer the degree program in: Master's in Education.

The Commission voted unanimously to approve the application for Provisional licensure submitted by the International Teachers University for one (1) year, not to exceed June 30, 2024.

#### b. Renewals/Amendment Applications

# i. Johns Hopkins University

Johns Hopkins University submitted an amendment application for an additional location at address 555 Pennsylvania Avenue, NW Washington, DC 20001 to offer various degree programs.

The Commission voted (Affirmative: Lloyd, Petty, Segar; Abstentions: Crider) to approve with conditions the application requesting amendment for an additional location at address 555 Pennsylvania Avenue, NW Washington, DC 20001 submitted by Johns Hopkins University synchronous with the current licensure approval and with the following conditions to be met:

- A satisfactory site visit
- Submit a permanent Certificate of Occupancy

# ii. Moreland University

Moreland University submitted an application requesting continued participation in SARA.

The Commission voted unanimously to conditionally approve the application requesting continued participation in SARA on a Provisional stature submitted by Walden University contingent upon the following conditions to be met:

- Submit a plan requesting the documents from Investment Holdings, LLC within 7 days
- Submit all final documents such as; an audit and composite scores no later than September 15, 2023

## c. Cases and Show Cause

# i. C2023-001 – Eric Amofa vs St. Michaels College of Allied Health

The Higher Education Licensure Commission received an emailed complaint dated October 19, 2022, from Mr. Eric Fosu Amofa that indicated that in February 2022 he filed a complaint with the Office of the Attorney General detailing several concerns he had about the school regarding financial aid, dropout rates, attendance policies, retaliation, intimidation and general unprofessionalism. Mr. Amofa's email did not include documentation to substantiate his claims.

Mr. Amofa's official complaint to the Higher Education Licensure Commission falls under 5 DCMR § A8117 Student Records. Specifically, 5A DCMR § 8117.2 which states "A school shall maintain as a permanent record and provide, upon request, a transcript to the student who has satisfied all financial obligations currently due and payable to the school.

In the case of, C2023-001 – Eric Amofa vs St. Michaels College of Allied Health said parties shall proceed via hearing on the matters that the HELC has jurisdiction. The former student Mr.

Amofa and the St. Michaels College of Allied Health will receive written correspondence regarding the scheduled dates and times for a hearing.

# ii. Adult Career Technical Academy

The Adult Career Technical Academy sent communication to the District of Columbia City Council stating that they had been operating in the District of Columbia since calendar year 2017. The Commission does not have any confirmation of the institution to have ever applied for licensure or have been licensed to do so.

Subsequently, Adult Career Technical Academy has been asked to speak to the Commission about their unlicensed activity in the District of Columbia.

The Commission accepted the explanation to the claims that were communicated to the City Council that The Adult Career Technical Academy were allegedly operating in the District without licensure. Additional clarity was provided in the relationship of affiliation between Career Technical Academy (ACTA) and Westlink Career Institute. Ms. Deborah Hayman has asserted on the public record that the institution did not operate independently. Ms. Hayman is intending to seek licensure with the Commission to properly operate within the District.

#### iii. Westlink Career Institute

The Commission took the action to deny licensure renewal of Westlink Career Institute. Ms. Hayman, on behalf of Westlink Career Institute, requested a hearing on the denial.

The day before the hearing was scheduled to occur, Ms. Hayman, on behalf of Westlink Career Institute, withdrew the request for hearing.

HELC staff subsequently sent a letter to Westlink Career Institute requesting that the institution move forward with the appropriate closure process, which would include the surrender of academic records,

proper notice to any students or business affiliates, and a final site visit to confirm that the facility where the program was operating, had in fact shut down.

The Commission voted unanimously to refer this issue of Westlink Career Institute and its outstanding document enclosure activities to the Office of the Attorney General for the District of Columbia.

## XII. Correspondence and Communications

## A. Informational

i. US DOE FSA

RE: Technical Learning Center DBA Prospect College

In a letter stamp dated June 28, 2023; providing update to the U.S. Department of Education advised Prospect College that it's application for recertification to participate as an eligible institution in the student financial assistance programs authorized pursuant to Title IV of the Higher Education Act of 1965, as amended, 20 U.S.C. § 1070 et seq. ("Title IV, HEA programs") had been denied. Prospect subsequently requested that this decision be reconsidered ("Reconsideration Request").

34 C.F.R. §§ 668.26(a)(l), 685.214 (a)(2). Since Prospect ceased offering instruction on May 31, 2023, its eligibility in the Title IV, HEA programs ended and a request for reconsideration of the recertification denial is moot. Consequently, the Department will take no further action on the request.

No action required by the Commission at this time.

# ii. Strayer University

RE: Notice of New Programs and Course Changes

In a letter dated July 20, 2023; providing notification of several new program offerings at Strayer University. Based on our ongoing assessment and program review activities, the University decided to add new concentrations and certificates, at both the undergraduate level and the graduate level. Specifically, the University will be adding: a new Bachelor of Science in Information Technology (BSIT) Artificial Intelligence (AI) concentration and corresponding Undergraduate Certificate in AI; a new Master of Science in Information Systems (MSIS)

Artificial Intelligence (AI) Management Systems concentration and corresponding Graduate Certificate in Artificial Intelligence (AI) Management Systems; two new concentrations for the Master of Education (M.Ed.) program: Educational Technology Leadership and Technology Innovations for Education; and a new M.Ed. Graduate Certificate in Instructional Design and Technology in conjunction with the existing M.Ed. Instructional Design and Technology concentration.

These changes are designed to better align with student goals and are consistent with Strayer University's long-term mission to provide high-quality education to working adults that will ensure their educational programming remains relevant for the changing needs of the workforce. Based upon previous guidance from our institutional accreditor, the Middle State Commission on Higher Education, the changes will not require substantive change review since these changes, "do not represent a significant departure in content or delivery from the degree or non-degree programs that are offered at Strayer University." These changes are collectively made in an effort to increase industry relevance and increase graduate opportunity for employment within their field of study.

No action required by the Commission at this time.

# Course Change: Bachelor of Science in Criminal Justice:

In a letter dated July 6, 2023; providing notification of a proposed course change to Strayer University's Bachelor of Science in Criminal Justice (BSCJ) degree. This change is designed to better align with student goals and are consistent with Strayer University's long-term mission to provide high-quality education to working adults that will ensure their educational programming remains relevant for the changing needs of the workforce. Based upon previous guidance from our institutional accreditor, the Middle State Commission on Higher Education, this change will not require substantive change review since the change, "do not represent a significant departure in content or delivery from the degree or non-degree programs that are offered at Strayer University." For the course change, students in the BSCJ will no longer be required to take BUS 100("Introduction to Business") as part of their major courses. Instead, they will be required to take SOC 210 ("Social Intelligence"). After reviewing industry skills, the University determined that SOC 210 was a better fit for students in the BSCJ program than BUS 100. Specifically, an integral skill for criminal justice is the ability to build rapport with anyone quickly. Being able to build a connection with anyone from any socio-economic background, age, gender, and race is critical, no matter which job is being sought in the criminal justice system. SOC 210 provides students with opportunities to learn these skills.

No action required by the Commission at this time.

iii. Walden University
RE: Legal Matters Update

In a letter dated July 6, 2023; providing update on Walden University's legal cases, as required by the Higher Education Licensure Commission's ("HELC") April 15, 2023 approval letter. During the April 2023 HELC meeting, the Commission inquired on two legal cases, Sweet v. Cardona and Carroll v. Walden University.

#### Sweet v. Cardona:

The class action suit is between the Department of Education and students with borrower defense applications. Walden is not a party to the case. The settlement does not determine any wrongdoing of any universities; it forgives the loans from listed institutions and outlines a timetable for doing so.

## Carroll v. Walden University:

On January 12, 2022, Walden was served with a complaint filed in the United States District Court for the District of Maryland by Aljanal Carroll, Claudia Provost Charles, and Tiffany Fair against Walden for damages, injunctive relief, and declaratory relief on behalf of themselves and all other similarly-situated individuals alleging violations of Title VI of the Civil Rights Act of 1964, along with additional state and federal law violations. Plaintiffs allege that Walden has targeted, deceived, and exploited Black and female Doctor of Business Administration ("DBA") students by knowingly misrepresenting and understating the number of "capstone" credits required to complete the DBA program and obtain a degree. Plaintiffs filed an amended complaint to add an additional plaintiff, Tareion Fluker. Walden answered the amended complaint on February 2, 2023. The parties have agreed to a non-binding mediation scheduled which began on May 4,2023. Discovery is stayed through the end of July and discussions between the parties are ongoing.

No action required by the Commission at this time.

#### B. Action

i. Bethel Training Institute

RE: Letter of Request

In a letter dated July 17, 2023; from Carol J. Grant-Gordon requesting that the Commission renew Bethel's license at this time. For the reasons set forth below:

As stated; a site inspection for Bethel Training Institute's renewal application, is currently pending. I understand that the Commission is waiting for the Board of Nursing to make a decision on Bethel's licensure before deciding on the renewal application.

Bethel's hearing with the Board of Nursing is currently scheduled for September 6, 2023 (see attached). At that time, our legal counsel intends to present evidence to the Board as to why it should approve Bethel's license to continue to train Home Health Aides in the District of Columbia. Until then, however, Bethel is currently unable to enroll new students, and this has a direct adverse impact on the school's financial resources and ongoing healthcare crises in the District of Columbia.

Bethel's licensure has been questioned solely because of what the Board deems a "low pass rate" without taking into consideration any of the underlying reasons or mitigating factors. Restricting Bethel's ability to train new Home Health Aides, even at a lower passage rate than some of its peers, is fundamentally inconsistent with the overwhelming consensus among industry leaders that barriers need to be taken down to promote an influx of new home health aides, not limit available options in a time of national crisis. On behalf of Bethel, we are inviting your Commission be part of the solution and not create another administrative hurdle that will harm the health care system as a whole.

Renewing Bethel's licensure so that we can continue our mission is certainly in the best interests of all involved.

# ii. Norwich University

RE: Annual Data Survey (ADS) Late Fee Waiver Request

In an email dated July 27, 2023; from James "Jim" A. Graves; the institution has requested a waiver for late fees of the annual data survey due to the following reasons:

"The program for which Norwich needed HELC's endorsement (Career LAB in DC) was canceled at the end of last Spring semester (May 2023). We had no need to reapply to HELC after that point. I, as university internship coordinator, was asked to take on the annual HELC application last year from our compliance attorney. I had very little instruction on how to do this and basically figured it out on my own. I was not aware of the survey requirement, so when I saw "HELC" in the subject line in March, I ignored the two emails thinking that it was asking for a renewed application for the current academic year. I admit that this was a mistake, and when I realized what had happened, I promptly completed the survey."

The Commission voted unanimously to proceed with the accrual of the fine, in the amount of five-hundred dollars (\$500.00) to Norwich University for late submission of the annual data survey (ADS).

## iii. Colgate University

RE: Annual Data Survey (ADS) Late Fee Waiver Request

In a letter dated June 7, 2023; from Andrew W. Fagon; requesting a waiver for late fees of the annual data survey due to the following reasons:

"On May 2, 2023, I received your letter, which states that Colgate University was in violation of the District of Columbia laws 5-A DCMR 8013 and 5-A DCMR 8122.2U).

We regret that we are in violation of this request and respectfully ask that the Higher education licensure Commission waive the \$500 fine that has been imposed on Colgate University.

We make this request for the following reasons:

- Colgate University did not operate a program in 2021 and 2022;
- Colgate University has completed all applications and paid all required application fees and all late fees (total \$10,500), allowing the university to operate its program this year, 2023.
- Colgate University completed and submitted the outstanding survey on June 6, 2023."

The Commission voted (Affirmative: Crider, Lloyd, Segar; Abstentions: Petty) to proceed with the accrual of the fine, in the amount of five-hundred dollars (\$500.00) to Colgate University for late submission of the annual data survey (ADS).
